



## **Race to Savings \$2,500 Grocery Sweepstakes**

### **OFFICIAL RULES**

Bashas' Inc., their subsidiaries and affiliated companies (together, the "Company"), will conduct the Contest substantially as described in these rules, and by participating, each participant agrees' as follows:

**1. Description of Contest:** Bashas' Race to Saving Event Sweepstakes. Every time a customer purchases three (3) participating Race to Savings Event Food items, in a single transaction, using their Bashas' Thank You Card between 02/15/17 and 03/21/17, they will receive a promotional code at the bottom of the receipt to text to enter the sweepstakes.

**2. Dates of Contest:** The Contest will begin on or about **February 15, 2017** and end on or about **March 21, 2017**.

**3. How to Enter:** Enter two ways: By Texting keyword found at the bottom of your Bashas' register receipt. Limit one text entry per person per mobile device per 24 hour period. OR by filling out a 3 X 5 card to include Name, Address, City, State, Zip Code, Phone Number, and Date of Birth and mailing it to: Bashas' Race to Savings Event Sweepstakes, P. O. Box 40165, Phoenix, AZ 85067-0165. No more than one entry per envelope.

**4. Other Requirements:** No Purchase necessary. **YOU MUST BE 18 YEARS OF AGE AND A UNITED STATES RESIDENT TO PARTICIPATE.**

**5. Prize(s):** Sweepstake Prize: GRAND Prize: ONE (1) \$2500.00 Bashas' Gift Card (*Grand Prize awarded in FIVE (5) \$500.00 Bashas' Gift Cards*), FIRST Place Prize: (5) \$500.00 Bashas' Gift Card. (*FIRST Place prize will be awarded in ONE (1) \$500.00 Bashas' Gift Cards*). ARV of all prizes is \$5000.00. Total of ONE (1) Grand Prize winner and FIVE (5) First Place Prizes. All other expenses are the sole responsibility of the winners. Gift Cards can only be used in Bashas' Supermarket stores.

**6. Eligibility, and Limitations:** All mail must be received by March 21, 2017 at 11:59pm. Participants and winner(s) must be **U.S. residents, Current address and Valid Driver's License in Arizona** and at least 18-years old as determined by the Company. Only one (1) prize per household will be allowed for the Contest. Prize is non-transferable. HP2 or the Company will not substitute winnings with different prizes or monetary compensation. Employees of Bashas' Inc., their parent companies, affiliates, subsidiaries, agents, and advertising and promotion agencies, and the immediate family and household members of such employees are

**9.
