OFFICIAL RULES

- 1. SWEEPSTAKES PERIOD:** Sweepstakes begins at 12:00 a.m. MT on 2/12/18 and ends at 11:59 p.m. MT on 3/31/18 ("Sweepstakes Period").
- 2. HOW TO ENTER:** During the Sweepstakes Period, you can enter via the following methods: **(a) TEXT MESSAGE:** Use your mobile phone to text "SUITE" to 69803 and you will be automatically entered into the Sweepstakes. Participants must have a mobile phone with text messaging capabilities to enter by text message and may incur standard text message and data charges from their wireless service provider for each message sent and received. Approximately a total of three (3) text messages will be required to participate. Check with your wireless service provider for details on any applicable charges.
