



Egg-cellent Carton Creation Contest

OFFICIAL RULES

1. NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN THIS CONTEST. VOID IN PUERTO RICO, U.S. VIRGIN ISLANDS, U.S. TERRITORIES AND POSSESSIONS AND WHERE PROHIBITED OR RESTRICTED BY LAW.

2. HOW TO ENTER: Contest begins on 4/5/17 and ends on 4/30/17 (“Contest Period”). Enter by sending an email with your child’s entry to creativecartons@bashas.com. All entries must be received by 11:59 p.m. on 4/30/17. Submission must include a photo of your child’s egg carton creation with a description (100 words or less). Limit one entry per person and per household. Neither Bashas’, Inc. (“Bashas’”), nor their respective employees, representatives or agencies, is responsible for lost, late, damaged, delayed, destroyed, misdirected, incomplete, or illegible entries. Once submitted, entries and donut concepts will become the exclusive property of Bashas’, Inc. 3. ELIGIBILITY: Open only to legal U.S. residents of AZ who are between the ages of 3-10 at time of entry. Employees of Bashas’, Inc., their respective parents, subsidiaries, and other affiliated companies, agents, advertising and promotional agencies, and their immediate families or persons residing in the same household of such employees are not eligible to enter or win.
