



Pepsi® 2016 Ultimate Super Bowl Home Party Package Sweepstakes Official

Rules at Bashas'

1. SWEEPSTAKES PERIOD: Sweepstakes begins at 12:00 a.m. MT on 12/7/16 and ends at 11:59 p.m. MT on 1/27/17 ("Sweepstakes Period").

2. HOW TO ENTER: During the Sweepstakes Period, you can enter via the following methods: **(a) TEXT MESSAGE:** Use your mobile phone to text "**SB51**" to 69803 and you will be automatically entered into the Sweepstakes. Participants must have a mobile phone with text messaging capabilities to enter by text message and may incur standard text message and data charges from their wireless service provider for each message sent and received. Approximately a total of three (3) text messages will be required to participate. Check with your wireless service provider for details on any applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate. By entering this Sweepstakes via text messaging the entrant is consenting to receive text and phone messages regarding the Sweepstakes. Entrants will be given the opportunity to "cancel" (or unsubscribe) each time they receive a text message by sending "STOP" to the short code above; or **(b) MAIL IN:** hand print your name, complete street address, date of birth and daytime phone number on a 3 x 5 inch paper. In the event of dispute over the identity of a potential winner, a text message entry will be declared made by the authorized account holder of such wireless phone number submitted at the time of entry, and potential winner may be required to provide identification sufficient to show that he/she is the authorized account holder of such wireless phone number. It is the sole responsibility of the entrant to notify the Sponsor in writing if the entrant changes his or her wireless phone number or postal address during the Sweepstakes Period. Proof of mailing/texting does not constitute proof of delivery or entry. All entries become the property of Sponsor and will not be acknowledged or returned. macro, bot or sweepstakes service) will be disqualified and transmissions from these or related email/IP addresses or wireless phone number may be blocked.

3. ELIGIBILITY: The Sweepstakes is open only to individuals who are legal residents of the United States, residing in AZ, who are 18 years of age or older at the time of entry. First Prizes (5): Five (5) First Prizes will be awarded, each consisting of one (1) \$100 NFLShop.com gift card. Actual Retail Value: \$100. If a winner cannot accept the prize as specified, prize will be forfeited and awarded to an alternate winner.

5. DRAWING: Potential winners will be selected in a random drawing from among all eligible entries received from all methods of entry throughout the Sweepstakes Period. Odds of winning depend upon the total number of eligible entries received. Drawing will occur after noon on or about 1/30/17 and will be conducted by an independent judging organization, whose decisions shall be final and binding. All prizes will be awarded.

6. WINNER NOTIFICATION: Potential winners will be notified by text, phone, mail and/or email at the phone number, mail and/or email address provided upon entry, within one (1) day of the drawing. If a potential prize winner is notified by text or phone, he/she will be required to respond within forty-eight (48) hours or prize will be forfeited and may be awarded to an alternate winner. Sponsor is not responsible for suspended or discontinued wireless service which may result in a potential winner not receiving initial prize notification. Once potential winner notification is confirmed to Sponsor, the potential grand prize winner will be sent an Affidavit of Eligibility and Liability/Publicity Release to be signed and returned within the number of days indicated on the Affidavit.
