



## Lipton Mango Trip Sweepstakes @ Bashas'

### Official Rules

**NO PURCHASE NECESSARY. MESSAGE AND DATA RATES MAY APPLY. VOID WHERE PROHIBITED.**

**1. SWEEPSTAKES PERIOD:** Sweepstakes begins at 12:00 a.m. (midnight) MT on 4/3/17 and ends at 11:59 p.m. MT on 5/6/17 ("Sweepstakes Period").

**2. HOW TO ENTER:** During the Sweepstakes Period, you can enter via the following methods: **(a) TEXT MESSAGE:** Use your mobile phone to text "**MANGO**" to 69803 and you will be automatically entered into the Sweepstakes. Participants must have a mobile phone with text messaging capabilities to enter by text message and may incur standard text message and data charges from their wireless service provider for each message sent and received. Approximately a total of three (3) text messages will be required to participate. Check with your wireless service provider for details on any applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate. By entering this Sweepstakes via text messaging the entrant is consenting to receive text and phone messages regarding the Sweepstakes. Entrants will be given the opportunity to "cancel" (or unsubscribe) each time they receive a text message by sending "STOP" to the short code above; or **(b) MAIL IN:** hand print your name, complete street address, date of birth and daytime phone number on a 3 x 5 inch paper. Each entry must be mailed separately in a hand-addressed, stamped envelope. Mail-in entries must be postmarked by 5/6/17 and received by 5/11/17 to be eligible for the drawing. No photocopied or mechanically reproduced entries accepted. Sponsor not responsible for lost, late, incomplete, illegible, misdirected entries or postage-due mail.

Limit one (1) entry per day per person. A "day" is defined as a twenty-four (24) hour time period beginning at 12:00 a.m. (midnight) MT and ending at 11:59 p.m. MT. The time clock of the Sweepstakes administrator is the official clock for this Sweepstakes.

In the event of dispute over the identity of a potential winner, an online or text message entry will be declared made by the authorized account holder of such email address or wireless phone number submitted at the time of entry, and potential winner may be required to provide identification sufficient to show that he/she is the authorized account holder of such email address or wireless phone number. It is solely the responsibility of the entrant to notify the Sponsor in writing if the entrant changes his or her e-mail, wireless phone number or postal address during the Sweepstakes Period. Proof of emailing/texting does not constitute proof of delivery or entry. All entries become the property of Sponsor and will not be acknowledged or returned. Each entry submission must be manually key stroked and manually entered by the individual entrant; automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or sweepstakes service) will be disqualified

and transmissions from these or related email/IP addresses or wireless phone number may be blocked.

**3. ELIGIBILITY:** The Sweepstakes is open only to individuals who are legal residents of the United States, residing in AZ or NM who are 18 years of age or older at the time of entry. Employees, contractors, directors and officers of Bashas', PepsiCo, Inc., Pepsi Beverages Company ("Sponsor"), Pepsi-Cola Company and its bottlers, and each of their respective parents, subsidiaries and affiliated companies, distributors, Web design, advertising, fulfillment, judging and promotional agencies involved in the administration, development, fulfillment and execution of this Sweepstakes (collectively "Sponsor and Promotion Parties") and the immediate family members (spouse, parent, child, sibling, grandparent, and/or "step" of each) and those living in the same households as such employees are not eligible to participate.

Winner and travel guest must travel on the dates specified by Sponsor. No alternate dates are available. Winner and travel guest must travel on same itinerary. Winner and travel guest must possess all necessary documentation required for air travel (e.g., valid photo identification). Any minor travel guest must be accompanied at all times by winner who must be the minor's parent or legal guardian. Meals, gratuities, transportation to and from winner's home and airport and other expenses not specifically mentioned herein are the winner's responsibility. Sponsor assumes no responsibility for canceled, delayed, suspended or rescheduled events (including, but not limited to airline flights, events) beyond its control. Drawing will occur on or about **5/12/17** and will be conducted by an independent judging organization, whose decisions shall be final and binding.

If a potential prize winner is notified by text or phone, he/she will be required to respond within seventy-two (72) hours or prize will be forfeited and may be awarded to an alternate winner. Sponsor is not responsible for suspended or discontinued wireless service, which may result in a potential winner not receiving initial prize notification. Once potential winner notification is confirmed to Sponsor, the potential prize winner will be sent an Affidavit of Eligibility and Liability/Publicity Release to be signed and returned. In the event (i) the attempted notification is returned as undeliverable without a forwarding address; (ii) a telephone or text message notification is not confirmed to Sponsor within seventy-two (72) hours; (iii) any required documents are not returned within the required number of days; or (iv) if winner is otherwise unable to attend an event when specified or accept the prize as stated, prize will be forfeited and may be awarded to an alternate winner. Allow three (3) to six (6) weeks for delivery of the prize following the notification process. Prize will only be delivered to an address within AZ or NM.

Sponsor may modify and amend these Official Rules as they may appear online from time to time during the Promotion for clarification purposes without materially affecting the terms and conditions of the Sweepstakes.
