

Pepsi® “2017 Learn To Ski Program” at Bashas’

OFFICIAL RULES

NO PURCHASE NECESSARY. MESSAGE AND DATA RATES MAY APPLY. VOID WHERE PROHIBITED. MULTIPLE DEADLINES APPLY.

1. SWEEPSTAKES PERIOD: Sweepstakes begins at 12:00 a.m. MT on 1/2/17 and ends at 11:59 p.m. MT on 2/15/17 (“Sweepstakes Period”).

2. HOW TO ENTER: During the Sweepstakes Period, you can enter via the following methods: **(a) TEXT MESSAGE:** Use your mobile phone to text “**SKI**” to 313131 and you will be automatically entered into the Sweepstakes. Participants must have a mobile phone with text messaging capabilities to enter by text message and may incur standard text message and data charges from their wireless service provider for each message sent and received. Approximately a total of three (3) text messages will be required to participate. Check with your wireless service provider for details on any applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate. By entering this Sweepstakes via text messaging the entrant is consenting to receive text and phone messages regarding the Sweepstakes. Entrants will be given the opportunity to “cancel” (or unsubscribe) each time they receive a text message by sending “STOP” to the short code above; or **(b) MAIL IN:** hand print your name, complete street address, date of birth and daytime phone number on a 3½ x 5 inch paper. Each entry must be mailed separately in a hand-addressed, stamped envelope. Mail-in entries must be postmarked by 2/15/17 and received by 2/20/17 to be eligible for the drawing. No photocopied or mechanically reproduced entries accepted. Sponsor not responsible for lost, late, incomplete, illegible, misdirected entries or postage-due mail.

Limit one (1) entry per day per person. A “day” is defined as a twenty-four (24) hour time period beginning at 12:00 a.m. (midnight) MT and ending at 11:59 p.m. MT. The time clock of the Sweepstakes administrator is the official clock for this Sweepstakes

In the event of dispute over the identity of a potential winner, a text message entry will be declared made by the authorized account holder of such wireless phone number submitted at the time of entry, and potential winner may be required to provide identification sufficient to show that he/she is the authorized account holder of such wireless phone number. It is solely the responsibility of the entrant to notify the Sponsor in writing if the entrant changes his or her wireless phone number or postal address during the Sweepstakes Period. Estimated Retail Value: up to \$1,300. Prize must be used by the end of the 2017 ski season.

Hotel accommodations are subject to availability. First Prizes: Six (6) First Prizes will be awarded (one in each of six drawings, each consisting of one (1) standard hotel room for two (2) nights for two (2) persons at the Doubletree by Hilton in Flagstaff, AZ (Sunday-Thursday night occupancy only), two (2) Adult Learn to Ski Packages that includes one (1) full day lift pass to Snowbowl Ski Resort, ski or snowboard equipment rental and one (1) 2-hour ski lesson (blackout dates are January 14-16, 2017 and February 18-20, 2017) and one (1) set of two (2) full day lift passes (blackout dates are January 14-16, 2017 and February 18-20, 2017). **Estimated Retail Value: up to \$750. Prize must be used by the end of the 2017 ski season. Hotel accommodations are subject to availability.** Any minor travel guest must be accompanied at all times by winner who must be the minor's parent or legal guardian. Six First Prizes will be awarded, one in each of the weekly drawings. To be eligible for a First Prize drawing, entries must be received by 11:59 p.m. MT on the night before each scheduled drawing. Entries eligible for one drawing remain eligible for all subsequent drawings. Grand Prize drawing will occur on or about 2/21/17 and will be conducted by an independent judging organization, whose decisions shall be final and binding. All Prizes will be awarded.

6. WINNER NOTIFICATION: Potential winner will be notified by text, phone, mail and/or email at the phone number, mail and/or email address provided upon entry, within two (2) days of the drawing. Sponsor is not responsible for suspended or discontinued wireless service which may result in a potential winner not receiving initial prize notification.
