



Bashas' Sizzling Summer Sweepstakes

Bashas' Inc., their subsidiaries and affiliated companies (together, the "Company"), will conduct the Contest substantially as described in these rules, and by participating, each participant agrees' as follows:

1. Description of Contest: Bashas' Sizzling Summer Sweepstakes. Every time a customer purchases three (3) participating Sizzling Summer items, in a single transaction, using their Bashas' Thank You Card between July 19, 2017 and August 29, 2017, they will receive a promotional code at the bottom of the receipt to text to enter the sweepstakes.

2. Dates of Contest: The Contest will begin on or about **July 19, 2017 at 12:01am** and end on or about **August 29, 2017 at 11:59pm**.

3. How to Enter: Enter two ways: By Texting keyword found at the bottom of your Bashas' register receipt. Limit: One (1) text entry per wireless phone number per calendar day (for purposes of this Sweepstakes, a "calendar day" is defined as beginning at 12:00 AM ET and ending at 11:59 PM ET on any one (1) calendar date). OR by filling out a 3 X 5 card to include Name, Address, City, State, Zip Code, Phone Number, and Date of Birth and mailing it to: Bashas' Sizzling Summer Sweepstakes, P. O. 4. Other Requirements: No Purchase necessary. **YOU MUST BE 18 YEARS OF AGE AND A UNITED STATES RESIDENT TO PARTICIPATE.**
